CRITICISM OF A NON-WHITE PERSON BY A WHITE WOULD POTENTIALLY BE A CRIMINAL CONSPIRACY

**A BILL**

to create white supremacy inspired hate crime and conspiracy to commit white supremacy inspired hate crime and to amend title and the scope of hate crimes

By the Senate and House of Representatives of the United States of America in Congress assembled

**SHR TITLE:**

to read as the “Leading Against White Supremacy Act of 2023”

**CRIMINALITY INSPIRED HATE CRIME:**

**SEC. 1.**—A person engages in a white supremacy inspired hate crime when white supremacy ideology has motivated the planning, action, or preparation of actions that constituted a crime or were subversive or interference of activity that, if effectuated, was a crime.

**SEC. 2.**—A conspiracy to engage in white supremacy inspired hate crime shall be deemed to exist—

(a) if two or more persons engaged in the planning, development, preparation, or preparation of a white supremacy inspired hate crime; or

(b) if at least one of those engaged in the planning, development, preparation, or preparation of a white supremacy inspired hate crime is at least one of those published material advancing white supremacy, white supremacy ideology, antagonism based on “legitimate hate speech that critics in a collective demand against any non-White person or group, and such published material—

(1) was published on a social media platform or by other means of publication with the likelihood that it would be viewed by a person engaged in or action or interference of a white supremacy inspired hate crime, or who are susceptible to being engaged in actions or interference of a white supremacy inspired hate crime;

(2) could, as determined by a reasonable person, motivate actions by a person predisposed to engaging in a white supremacy inspired hate crime; or

(3) was read, heard, or viewed by a person who is susceptible to being motivated to engage in actions relating to a white supremacy inspired hate crime.

(c) was read, heard, or viewed by a person who engaged in the planning, development, preparation, or preparation of a white supremacy inspired hate crime.



US Congressman Sheila Jackson Lee has represented the 18th district of Texas since 1995. She is the sole sponsor of **House Bill 61**, which she introduced on January 9th, 2023.

She titled the bill “Leading Against White Supremacy Act of 2023.” It calls for a new type of federal hate crime conspiracy charge that only White people can be charged with,

It says that individuals can be charged with a “White supremacy inspired hate crime,” for crimes or plots they had no actual knowledge of.

The bill says that any White person who criticizes immigration or vilifies any “non-White person or group” can be charged with committing a federal hate crime conspiracy. The only thing necessary to charge you with this crime is for someone else, who read something you wrote, to commit or plot a crime. This could be something as minor as a post on social media.

The bill would be a soft repeal of the US Constitution’s first amendment.

On the same day that Jackson introduced HR 61, she also co-introduced **HR 40**, which calls for a federal commission on reparations for slavery. Ultimately the purpose would be to give free money to Black Americans. A total of fifty-two Democrats are currently sponsoring HR 40.

(b) CONSPIRACY.—A conspiracy to engage in white supremacy inspired hate crime shall be determined to exist—

(1) between two or more persons engaged in the planning, development, preparation, or perpetration of a white supremacy inspired hate crime; or

(2) between two or more persons—

(A) at least one of whom engaged in the planning, development, preparation, or perpetration of a white supremacy inspired hate crime; and

(B) at least one of whom published material advancing white supremacy, white supremacist ideology, antagonism based on “replacement theory”, or hate speech that vilifies or is otherwise directed against any non-White person or group, and such published material—

(i) was published on a social media platform or by other means of publication with the likelihood that it would be viewed by persons who are predisposed to engaging in any action in furtherance of a white supremacy inspired hate crime, or who are susceptible to being encouraged to engage in actions in furtherance of a white supremacy inspired hate crime;

(ii) could, as determined by a reasonable person, motivate actions by a person predisposed to engaging in a white supremacy inspired hate crime or by a person who is susceptible to being encouraged to engage in actions relating to a white supremacy inspired hate crime; and

(iii) was read, heard, or viewed by a person who engaged in the planning, development, preparation, or perpetration of a white supremacy inspired hate crime.


